

## DOCUMENTATION REQUIRED PRIOR TO ENROLMENT AT BROWNS BAY SCHOOL

The documentation listed on check list below will be required immediately prior to a child starting at Browns Bay School.

Students will not be able to start at school until this documentation is received by the school. Under legislation, the Board of Trustees has the right to annul any enrolment accepted on the basis of false information presented.

The Board of Trustees may review and annul the enrolment under Section 110A of the Education Act 1989.
